

ENTRY METHOD: RANDOM DRAW

ENTRIES WILL OPEN ON: Wednesday, July 23, 2025 at 8:00AM CDT. All entries received before this date will be returned with "Refused" written on the envelope. Overnight or certified mail must be sent with the "No Signature Required" waiver signed. Golden Retriever entries will be given priority. **Entries must be received by Friday, August 8, 2025 at 5PM CDT to be included in the Random Draw. The Draw will be held on Saturday, August 9, 2025 at 6PM CDT at the following address: 14151 Vale Court, Eden Prairie, MN 55346-3019.** At the draw, if the number of entries of Golden Retrievers is less than the overall trial limit, all Golden Retrievers will be accepted into the trial and the remaining entries will be subject to a draw. If the Golden Retriever entries on the draw date exceeds the trial limit, the Golden Retrievers will be subject to a draw and entries for all other breeds will be shredded.

ENTRIES CLOSE ON Thursday, August 21, 2025 at 6pm CDT after which time entries cannot be accepted, canceled, altered, or substituted except as provided for in Chapter 11, Section 6 of the Rules Applying to Dog Shows. Envelopes/transactions containing entries for more than the ten (10) dog maximum and/or entries received prior to the opening date shall be treated as an invalid entry and shall be returned to the sender.

All exhibitors should obtain a copy of the most current **Regulations for Scent Work Trials** by downloading it from the American Kennel Club website (www.akc.org).

DOGS ELIGIBLE TO ENTER

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration. Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate.

Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete. Wherever the word "dog" is used in these regulations, it includes both sexes.

Dogs with physical challenges (including amputees) are eligible to participate provided that, in the opinion of the judge, the dog displays no sign of physical discomfort and can safely complete the search. Deaf and blind dogs are allowed to enter. Females in season may not participate. Aggressive dogs, or dogs suffering from an injury or illness which may affect the dog's physical or mental performance, may not participate. No dog shall compete if it is sutured, bandaged, or has any visible wounds.

No entries will be accepted by phone, email, or fax. Express mail entries must include a signature waiver allowing them to be left at the secretary's address. No entry shall be made, and no entry shall be accepted, which specifies any conditions as to its acceptance. Illegible entries will not be processed and will be returned to the exhibitor. Returned checks do not constitute a valid entry. Club treasurer will add a \$35.00 collection fee to the amount of each returned check.

VOLUNTEERS HAVE PRIORITY ENTRY

Volunteers are extremely important to the success of any trial. **Volunteers numbering up to 25 per day will have priority entry into the trial.** To volunteer and have priority entry into the trial, contact Laurie Hanson at kimtuck@comcast.net well before the random draw date of August 9, 2025. **It is preferred that you be able to work the entire day.** If you volunteer after the random draw date, you will not be guaranteed priority entry. Please write "Volunteer" on your envelope and entry form and submit it such that the Trial Secretary receives it before the random draw.

Volunteers will be assigned to a team and will be with that team all day. We plan to use the myK9Q app (please see [page 6](#)), so we will need gate stewards, timers, and judge assistants who are eager to learn how it works. Instructions, including links to YouTube videos, will be e-mailed to you a couple of weeks prior to the show. Lunch will be provided for volunteers.

WAITLIST INFORMATION

All entries must be received by the Trial Secretary prior to Thursday, August 21st, 2025 at 5pm CDT. **No entries may be withdrawn for a complete refund after closing on Thursday, August 21st, 2025 at 5pm CDT** unless withdrawn entries are filled as follows: GTCGRC is offering a waitlist to fill openings created by entries that have been withdrawn after the trial's closing date/time. A maximum of **50 runs per day** will be placed on the club's waitlist. If runs of a withdrawn entry are replaced by waitlisted runs, a refund will be issued to the exhibitor of the withdrawn entry for those runs just filled. Exhibitors who were able to have some runs filled, but not all, will receive a refund after entry checks have cleared the bank for those runs that did not have openings. Checks will be shredded for exhibitors who were unable to have any of the runs requested on the entry.

REFUNDS

No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Event Committee.

Dogs pulled after closing because of injury or other medical condition are eligible for a full refund contingent on the Trial Secretary receiving verification of injury or illness by a qualified veterinarian no later than 24 hours before each trial starts.

Bitches in season will be refunded the full entry fee. Notification in writing must be given to the trial secretary no later than one half hour prior to the start of the first class on the day of the trial.

MOVE-UP INFORMATION

Move-ups will be accepted provided the level of the class you want to move up to is available. Move-ups will be accepted for the next day. There will be no same day move ups. Move-up (AKC Class Transfer) forms must be completed and submitted to the Trial Secretary as soon as possible. Forms will be available or may be pre-printed from [this website link](http://images.akc.org/pdf/events/Scent_Work_Transfer_Form.pdf) or enter the address: (http://images.akc.org/pdf/events/Scent_Work_Transfer_Form.pdf) Please include your **dog's call name** on the form and ensure your information is clearly legible. If moving up from Excellent to **Master**, you must include an **extra \$5.00** with your move-up form. You may not move up to Detective as it is a separate class.

STAGING AREA, HANDLER'S BRIEFING, AND WARM-UP INFORMATION

Staging Area will be out of view of search area(s). Staging area will include crating, warm-up and waiting area, as well as the secretary table for check-ins and posting of running order and results. There will be **no inside crating**.

The **Handler's Briefing** will take place in view of the search area prior to the start of each class, after the hide(s) have been set and after the Demo Dog has run. In the Handler's Briefing the judge will explain if there is an off-leash option, number of hides in lower classes, maximum height of hides and maximum time for the search. NO DOGS are to be present during the Handler's Briefing.

A **Warm-up Area** will be available consisting of ONE marked container of each odor being tested at the trial and may also consist of blank containers. Exhibitors should limit their warm-up to (2) two minutes or less. The warm-up area is to be used exclusively for warming up the handler-dog team prior to their run. The warm-up area is not for training or relieving of the dog. No handling teams are allowed in the warm-up area unless they are practicing just before they are called for their search.

SEARCH AREA AND RING CONDITIONS

Search areas may be of any shape, and of the size specified in the Regulations for AKC Scent Work for each class.

Search Area Conditions. Searches may be indoors, on matted, carpeted, or tiled surfaces, or outdoors on grass, gravel, earth, concrete, or asphalt surfaces in accordance with AKC Scent Work regulations.

CAMP EDEN WOOD SITE SPECIFICS

Camp Eden Wood is a beautiful retreat facility in a wooded area that was originally built in 1925 as the Glen Lake Children's Camp for kids with tuberculosis. Various buildings and exterior areas will be used as search areas.

It is approximately 550 feet along a gravel road from the check-in building to the search areas, a part of which is **on an incline** which may be physically challenging for some. There is an asphalt trail with less of an incline that traverses the hill along the north side of the road and parking areas. There is some parking part way up the hill. Ribbons will be in the Main Lodge.

All exhibitors will stage from their vehicles in designated parking areas. It is often difficult to predict Minnesota weather this time of year, so one should prepare for variations in wet/dry, cold/warm, or humid conditions. Be sure to check the latest weather forecast and bring what you need to keep you and your dog comfortable.

Crating will be in your vehicles. Please provide all items, including food and water, you and your dog will need to be comfortable in our sometimes difficult to predict Minnesota weather. Indoor bathrooms are in the main building.

Please bring your own lunch. There will be no food or beverages provided on the trial grounds.

ADDITIONAL SITE INFORMATION

Trial Site. It is not appropriate to scout the trial location prior to the trial date. Many search locations are real-life environments, and such visits may risk the host losing the opportunity to use the location in the future.

Possession of Odors and Training. Chapter 5. Section 35 of the Scent Work Regulations states "No person other than those engaged in the administration of a trial shall be in possession of any target odor when on the trial grounds. There shall be no training on the grounds of the AKC Scent Work trial, other than the designated warm-up area."

RIBBONS, AWARDS, AND PRIZES

Placement ribbons will be awarded in each class as follows:

First Place.....	Blue
Second Place.....	Red
Third Place.....	Yellow
Fourth Place.....	White
Qualifying Score.....	Dark Green

A **New Title rosette** will be awarded to all dog and handler teams who finish an Element or Level title.

A **High in Trial rosette** will be awarded to all dog and handler teams who qualify with the least number of faults (and fastest time, if a tie) of a particular difficulty level of all elements. The High in Trial award **does not** consider Handler Discrimination classes.

A **High Combined rosette** will be awarded to all dog and handler teams who qualify with the least number of faults (and fastest time, if a tie) of a particular difficulty level of all elements. The High Combined award **does** consider Handler Discrimination classes.

NOTICE TO EXHIBITORS

SAFETY, BEHAVIOR and LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all searches safely. **It is expressly understood** that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event Committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Greater Twin Cities Golden Retriever Club and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Greater Twin Cities Golden Retriever Club reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Greater Twin Cities Golden Retriever Club or any official thereof.

Collars, Leashes and Harnesses. During searches, dogs must wear a properly fitted collar or harness approved by the judge. Leashes may be of any length and/or retractable. The leash should be made of plain, pliable material. Please read Chapter 5 Section 13, page 33 in the rulebook for further information about proper equipment.

All dogs must be on leash at all times, and **retractable leashes may not be used when on trial grounds (except during judged searches)**. Dogs must enter and exit the search area with the leash attached to the collar or harness, including when waiting in the search area before and after the search. An off-leash option may be offered at the discretion of the judge, only if the area is completely enclosed.

Exhibitors are responsible for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the Retreat Center Grounds.

RINGSIDE

The Owner of each dog is solely responsible for having it ready at the search area when it is to be judged. The Club has no responsibility to provide service through a public address system or stewards or runners for the purpose of calling or locating dogs that are not brought into the ring when required.

EXHIBITOR CHECK-IN: Once the time and location for check-in are determined all exhibitors will be notified by email.

Exhibitors will check-in EACH day they are entered by using the myK9Q app (see next page) or by having a volunteer or fellow handler check-in for them. Detailed check-in times by class and instructions for using myK9Q will be included in the Trial Information Packet sent to all entered handlers a few days before the trial.

Claims will be arbitrated as set forth on the Official AKC Entry Form for this event.

"Exhibitors should follow their veterinarian's recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations." Additionally, clubs should include any specific local or state health requirements, for example, proof of rabies vaccination.

Required verbiage per October 2024 AKC Board of Directors meeting minutes:

USE MYK9Q TO CHECK-IN AND STAY INFORMED

We are planning to use the **myK9Q** phone app for use by exhibitors, gate stewards, timers, and judge assistants.

Exhibitors (handlers) use myK9Q to:

- ✓ Check-in, pull or declare a conflict for their dogs.
- ✓ View AKC details for each of their classes such as how many hides, run time and size of the search area.
- ✓ View the status of classes that are currently running, such as setup, briefing, in-progress, completed.
- ✓ View the running order of each class, including dogs that are yet to run and dogs that have completed their runs.
- ✓ View announcements that are broadcast to the group regarding upcoming classes, judges at lunch, etc.

Gate Stewards use myK9Q to:

- ✓ Update the status of your dog (check-in, at gate, absent), or move a dog within a class.
- ✓ Send announcements, such as "Looking for dog Sniffy for Interior Excellent."

Timers use myK9Q to:

- ✓ Set the run time for the class according to the judge.
- ✓ Start and stop the myK9Q stopwatch. myK9Q will prompt for the 30-second warning when applicable.
- ✓ The time is saved to the myK9Q cloud.

Judge Assistants use myK9Q to:

- ✓ Update class comments and/or send announcements, such as "Container Advanced est start time is 9:10am."

The Trial Secretary will use myK9Q to:

- ✓ Download scores from the myK9Q cloud into the trial software scoring system.
- ✓ Verify the standard paper scoresheet from the judge to the results just downloaded from myK9Q.
- ✓ Print the Preliminary Results report and the Result Labels for distribution to exhibitors.

The myK9Q app is not in any app store. Instructions with links to videos to get and use the myK9Q app will be included in the *Trial Information Packet* sent to all entered exhibitors a few days before the trial. Camp Eden Wood appears to have good cell service.

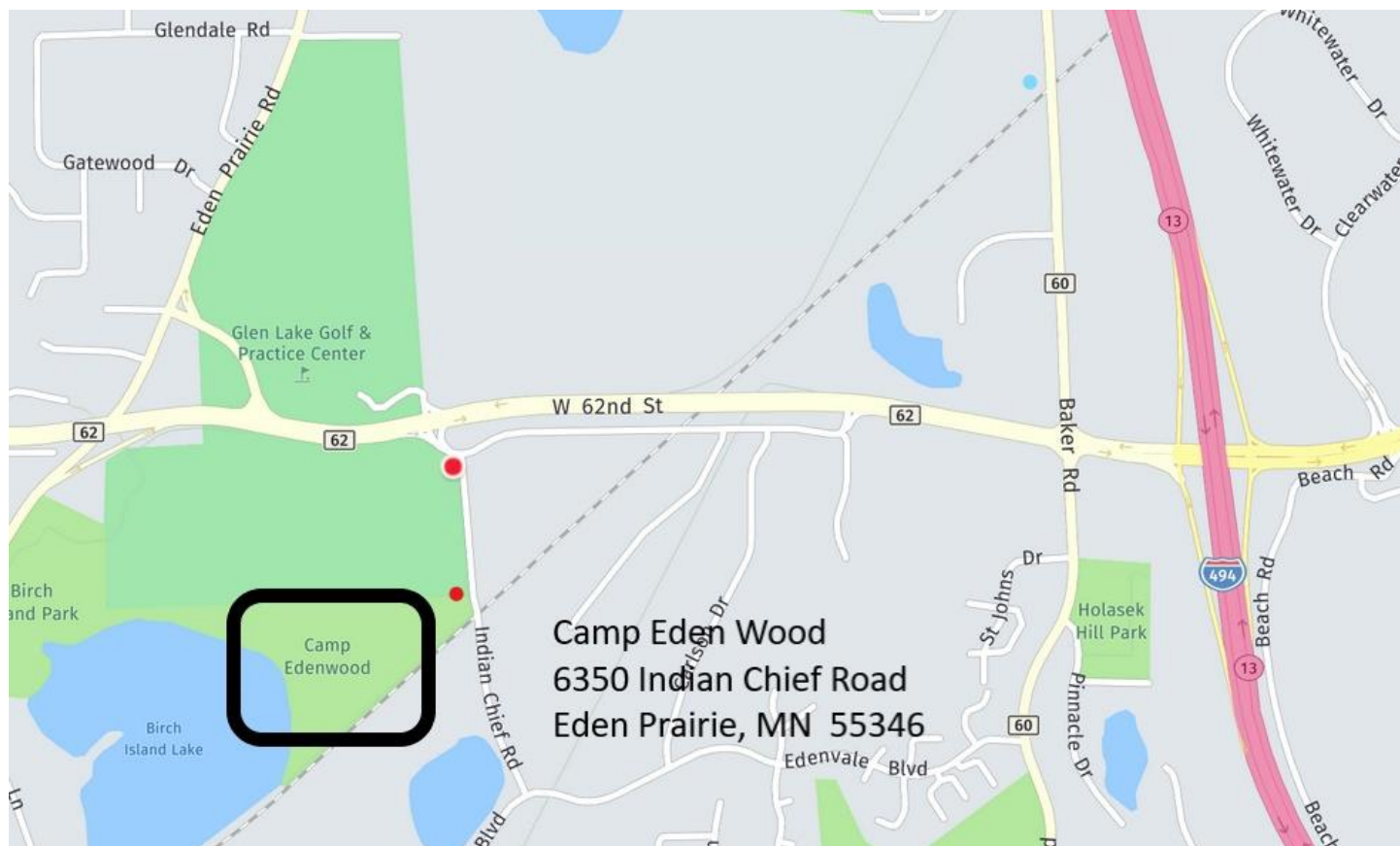

DIRECTIONS TO THE TRIAL SITE

From the North, South and East: take I-494 to Hwy 62 (Crosstown) – go West on Hwy 62 – turn Left (south) onto W. 62nd St. – make quick Right onto Indian Chief Road. Gravel driveway is on the right just before the one-lane overpass.

From the West: go east on Townline Road / Hwy 62 (Crosstown) and turn right (south) onto W 62nd St. – make quick Right onto Indian Chief Road. Gravel driveway is on the right just before the one-lane overpass.

Advisory: On rare occasions those navigating from the southwest through Eden Prairie via Edenvale Boulevard may find Indian Chief Road closed south of the railroad bridge due to seasonal flooding. If so, continue east along Edenvale Boulevard and take the next left (north) onto Carlson Drive. Go to the end of Carlson Drive and turn left (west) on W. 62nd Street. This is a frontage road that runs parallel to Hwy 62 (Crosstown). Follow W. 62nd Street a few blocks to the top of the slight hill at Indian Chief Road and turn left (south). Go down the hill on Indian Chief Road to Camp Eden Wood on the right just before the one-lane overpass.

In consideration of True Friends permitting the Participant to be present upon and use the facility commonly known as Camp Eden Wood, 6530 Indian Chief Rd., Eden Prairie, MN 55346 (the "Facility"), and/or participate in the Activities (as defined below) I, on my own behalf and on behalf of Participant if a minor, hereby waive liability on the part of, discharge and agree not to sue or to execute upon any judgment against, and release True Friends, its employees, representatives, directors, instructors, successors, or assigns (collectively, "True Friends"), from any and all liability, loss, injury, death, damages, costs, expenses, including costs and attorneys' fees, causes of action, and claims of any kind or type, which may have arisen, or may arise, while the Participant is present upon or using the Facility and/or participating in the Activities, except to the extent any claims arise out of or are the result of the grossly negligent or intentionally wrongful acts or omissions of True Friends.

ASSUMPTION OF RISK. I am fully aware that there may be risks and hazards associated with being present upon and using the Facility, and I, or the Participant, elect to voluntarily be present upon and use the Facility knowing that there may be risks or hazards. I acknowledge and agree, on my own behalf and on behalf of the Participant, that the Activities are inherently dangerous and subject the Participant to physical exertion and the possibility of physical illness or injury, ranging from minor to serious or catastrophic injuries and/or death.
